I understand that it is my responsibility to notify the Brampton Real Estate Board immediately if my account changes/closes.

I understand and agree to the foregoing terms and conditions. I acknowledge my copy as receipt of this Authorization.

I acknowledge that the Brampton Real Estate Board will charge my BREB account a service fee, set by the Board of Directors from time to time, if my PAD* is returned for reason of "Non-Sufficient Funds" or "Funds Not Cleared" or "Account Closed". Current charge for this is \$25.00 plus HST.
