Non-Active Sustaining Status

Any Member who is prevented from carrying on Real Estate Business by virtue of public service, physical disability or any other cause beyond his/her control may be granted Non-Active Sustaining Status by the Board of Directors upon:

- a. Submission of a completed application form to the Board of Directors including valid documentation;
- b. Approval by the Executive Officer and/or the Board of Directors by a majority vote;
- c. Payment of the appropriate fee of OREA CREA, and Term-Life Insurance.

Non-Active Sustaining Status will not be permitted to trade in real estate and will have their board membership charges waived.

The continuance of Non-Active Sustaining Status is at the discretion of the Executive Officer and/or the Board of Directors and may be terminated at any time by the Executive Officer and/or the Board of Directors and shall be reviewed annually. If deemed appropriate at any time by the Executive Officer and/or the Board of Directors, Non-Active Sustaining Status may be terminated.

On returning to active Real Estate Business, a Non-Active Sustaining Status may be reinstated as a Member, as applicable upon:

- a. Submission of the prescribed form or letter of request for reinstatement to the Board;
- b. Payment of pro-rated board charges in respect to the application type of membership for the year in which such Member is resuming active membership.

A Non-Active Sustaining Status individual will not be entitled to vote, to hold office or receive services, including but not limited to MLS® services.
